

**Logan Town Board Meeting Minutes  
December 10, 2024**

On December 10th, 2024 the Logan Town Board held its monthly meeting at the Palisade Community Center. Chair David Sims called the meeting to order at 7:06 pm.

Present: Supervisor Dave Sims, Supervisor Elissa Bryan, Supervisor Lynn Mizner, Treasurer Michelle Pieterse, Clerk Craig LeBlanc and Rod Kern.

- David Sims moved to approve the November 2024 minutes, second by Lynn Mizner. Motion passed with all in favor.
- Lisa Bryan moved to approve the Treasurer's Financial Statement, second by Lynn Mizner. Motion passed, all in favor.
- The Clerk's books balance with the Treasurer's books.

**Elections:**

- Lynn Mizner, Michelle Pieterse, David Sims and Craig LeBlanc received the Certificate of Election.
- Lynn Mizner, Michelle Pieterse, David Sims and Craig LeBlanc signed the Oath of Office.
- David Sims moved to approve Resolution 2024-6 Designating Polling Place (In-Person Voting), second by Lynn Mizner. Resolution passed with Lisa Bryan opposed.

**Old Business:**

- Logan Township Cannabis Resolution: Contact a lawyer about the issue and discuss further at the January meeting.

**Roads:**

- Workman Townline Road Agreement was sent today.
- Waukenabo Townline Road Agreement: A letter was sent to Waukenabo township about reviewing the maintenance done on 340th Lane and clarifying the maintenance agreement.
- The ditch at the corner of 330th Avenue and 480th Street (Robert Collins property) was partially cleared by the Aitkin County Highway Department. Other portions of the ditch are blocked by driveways and may require culverts.

**New Business:**

- MAT Annual Conference: Lynn Mizner, Michelle Pieterse and Craig LeBlanc are registered. Proposed resolutions concerning cellphone coverage, land transfer, EMS funding and rural mail delivery were reviewed. Cannabis issues will be brought up at the training sessions.

**Pine Grove Cemetery:**


