
- Lisa Bryan moved to approve the January 2025 Logan Town Board Meeting minutes, second by Dave Sims. Motion passed, all in favor.



## **Logan Town Board Meeting Minutes February 11, 2025**

### **Old Business:**

- PERA Exclusion Report was submitted and approved. All current Logan Township officers have previously declined all applicable PERA retirement plans and are excluded from future future participation in PERA as employees of Logan Township.
- 2025 Pay Equity Report was submitted.
- The November 11th Town Board Meeting falls on Veterans Day and needs to be rescheduled. The board agreed to move the meeting to November 12th at 7:00 pm.

### **Roads:**

- Haul Road Designation Forms for 330th Avenue and 470th Street - Hold for spring inspection.
- Brushing done on 509th Lane is almost completed. Red pines on 485th Street need trimming.

### **New Business:**

- January 2025 ACAT Meeting: Dave Sims and Craig LeBlanc attended. MAT Annual Conference was discussed and Dave Sims was elected as director of ACAT District 5.
- Group Term Life Insurance: Minnesota Benefit Association. Minimum coverage increased from \$2000 to \$5000 and the premium increased from \$32 to \$80. Officers over 70 years old receive a 50% benefit and those over 75 years old receive a 25% benefit. The board will continue coverage.
- MAT Township Day at the Capitol: Craig LeBlanc attended and discussed issues of annexation, road funding and EMS services.

### **Cemetery:**

- Current balance is \$16,679.61 for the Pine Grove Chapel Fund. No bids were received for repair/reconstruction this year. A notice will be put in the paper asking for bids.
- The cemetery information and by laws need to be updated.
