

Logan Town Board Meeting Minutes

January 13, 2026

On January 13th, 2026 the Logan Town Board held their monthly meeting at the Palisade Community Center. Chair Dave Sims called the meeting to order at 7:05 pm.

Present: Chair Dave Sims, Supervisor Elissa Bryan, Supervisor Lynn Mizner, Treasurer Michelle Pieterse, Clerk Craig LeBlanc and Rod Kern.

- Lisa Bryan moved to approve the December 2025 Logan Town Board Meeting minutes, second by Lynn Mizner. Motion passed, all in favor.
- Dave Sims moved to approve the Treasurer's Financial Statement with a total balance of \$144,427.74, second by Lynn Mizner. Motion passed, all in favor.
- The Clerk's books balance with the Treasurer's books.

Old Business:

- Waukenabo township will be billed for road maintenance paid for by Logan Township that they are responsible for in the current Townline Road Maintenance Agreement.
- Lisa Bryan moved to donate \$325.00 to the City of Palisade for use of the Palisade Community Center in 2025 (13 meetings), second by Dave Sims. Motion passed, all in favor.
- Lisa Bryan moved to donate \$125.00 to Sentenced to Serve for snow fence removal/installation, second by Lynn Mizner. Motion passed, all in favor.

Roads:

- Lynn Mizner moved to accept Kern Excavating's proposal to remove brush from the right of way on 312th Place, second by Lisa Bryan.

New Business:

- The 2027 City of Palisade Fire Protection Agreement was signed.
- PERA: Options to decline participation in the retirement plan are permanent. There is no need for annual confirmation for members of the current town board.
- The MATIT Worker's Compensation Audit was submitted and approved.
- The Board of Audit will be held as part of the regular meeting on February 10th, 2026.
- Paid Leave started January 1, 2026. The township is paying the 0.66% of income cost.
- Dave Sims is planning a trip to Washington, D.C. as a township representative.
- Federal standard mileage rate is 72.5 cents per mile, effective January 1, 2026.

Cemetery:

- There is a \$242.00 donation to the Pine Grove Chapel Fund.

- Dave Sims nominated Lisa Bryan as Vice Chair, second by Lynn Mizner. Motion passed with Lisa Bryan abstaining.

David Sims moved to approve the following items without changes, second by Lynn Mizner.

Motion passed, all in favor:

- Town Board meetings are currently scheduled for the 2nd Tuesday of the month at 7:00 pm except for March, where the Town Board meeting follows the Annual Township Meeting.
- Annual Meeting Moderator's fee: \$30.00 per meeting.
- Town Board Supervisor's wage: \$150.00 monthly salary with \$150.00 per meeting and time worked over 2 hours a month at the regular labor rate of \$30.00 per hour.
- Clerk's wage: \$500.00 monthly salary with \$150.00 per meeting and time worked over 30 hours a month at the regular labor rate of \$30.00 per hour.
- Treasurer's wage: \$350.00 monthly salary with \$150.00 per meeting and time worked over 30 hours a month at the regular labor rate of \$30.00 per hour.
- Cemetery salary: \$100.00 per month with time worked over 8 hours at the regular labor rate of \$30.00 per hour.
- Deputy Clerk and Deputy Treasurer wages: \$75.00 per meeting.
- Regular labor rate is currently \$30.00 per hour.
- Financial institutions are Old National Bank, MCCU and Security State Bank.
- Aitkin Independent Age is currently the publication for township published notices.
- Palisade Community Center is currently the official posting location.

- Dave Sims moved to approve claims, second by Lisa Bryan. Motion passed, all in favor.
