Cemetery:

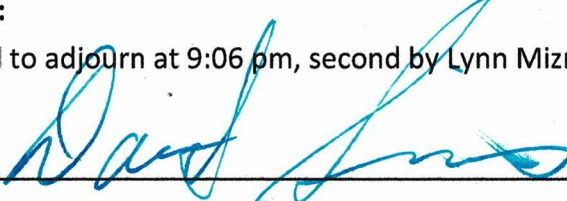
